



## A 'SAFE HOME' INCLUDES RX DRUG ABUSE PREVENTION

National Healthy Homes Month (NHHM), June 2017, is a month-long celebration that offers an opportunity to learn more about housing and its impact on health. When thinking of potential hazards in your home, it is common to think about radon, water, fire, injury prevention, and more. While these are important, we must not forget to protect against the hazard of underage drug use and drug misuse in our homes.

Prescription drug abuse is our nation's fastest growing drug problem. Many people have unused or expired medications in their home that can easily become a source of access for someone seeking medications for non-medical purposes.

More than 70% of those abusing prescription drugs obtain them from family members and friends. Prescription drug abuse can impact anyone regardless of their income, age, education level, etc., including friends, family, teachers, community leaders, and others.

How can you prevent drug abuse in your home?

- Monitor prescription drugs and over-the-counter medications. Take note of how many pills are in each of your prescription bottles and keep track of refills.
- Lock prescription drugs in a medicine cabinet or safe. Keep cabinet or safe in a
  place that is out of sight and out of reach of children.
- Safely dispose unused or expired prescriptions and over-the-counter medications at secure drop off locations.

In addition to prescription drugs, it is important to monitor and lock alcohol, tobacco, medical marijuana and other drugs if kept in your home.
