

## PERSON WITH HEPATITIS A ATTENDED MICHIGAN RENAISSANCE FESTIVAL IN HOLLY, MI DHD#10 Encourages Festival Attendees to get Hepatitis A Vaccine

September 14, 2018– The Oakland County Health Division is reporting that an individual, who is a confirmed case of hepatitis A, attended the Michigan Renaissance Festival while ill on September 1, 2018, in Holly, MI.

Because of the possibility of environmental contamination/transmission from the ill individual, vaccination within two weeks of exposure is strongly recommended for anyone who has not been previously vaccinated for Hepatitis A and attended or worked at the Festival at any time between September 1-3, 2018.

Those with Festival attendance on September 1 should seek vaccination by September 15, September 2 Festival attendees should get a hepatitis A vaccine by September 16 and September 3 attendees have until September 17 to receive a vaccination.

The Grand Traverse County Health Department (GTCHD) is offering a **Walk-In Hepatitis A Vaccination Clinic on Saturday, September 15, from 10:00am – 1:00pm at 2600 LaFranier, Traverse City, MI.** If you attended or worked at the Renaissance Festival, or if you have not yet been vaccinated for hepatitis A, consider getting vaccinated at this walk-in hepatitis A vaccination clinic in Traverse City.

Hepatitis A is an infection of the liver caused by a virus. The infection can range from a mild illness lasting several weeks to a serious condition lasting several months; some may die of liver failure. People who already have a chronic liver disease or are immune compromised are at a higher risk of developing a serious case of hepatitis A. Hepatitis A vaccine or immune globulin (IG) can provide protection against the disease if given within 14 days after potential exposure.

All festival attendees, especially those who are unable to receive a dose of vaccine by September 15, are advised to monitor themselves for symptoms of hepatitis A that could include sudden abdominal pain, diarrhea, nausea, headache, dark urine, clay-colored stools, and/or vomiting followed by yellowing of the skin and eyes. Anyone with these symptoms is advised to seek medical attention immediately. Symptoms may appear from 14–50 days after exposure.
