



## TOBACCO USERS AT AN INCREASED RISK FOR SEVERE ILLNESS FROM COVID-19

December 22, 2020- District Health Department #10 is encouraging current cigarette and e-cigarette users to set a 2021 New Year's resolution to guit smoking or vaping!

Cigarette smoking compromises the immune system and is linked to lung inflammation that puts people at greater risk for pulmonary infections, such as flu, pneumonia, bronchitis, and COVID-19. Smoking also harms the cells that line our airways which are the lungs essential defenders against viruses. Adults and youth that smoke or are former smokers are at an increased risk for severe complications of infection, including severe illness from COVID-19.

Although there is no firm link between e-cigarette use and severe risk due to COVID-19, there are other harms that remain. Nicotine, commonly found in e-cigarettes, can cause inflammation in lung tissue. E-cigarettes also contain a pesticide called, acrolein, which can cause acute lung injury and COPD and may cause asthma and lung cancer. All four of these are potential risk factors for developing severe COVID-19 symptoms.

It is important that we do all we can to keep our lungs healthy to avoid the worst effects of COVID-19. Smoking and vaping harms the lungs, making lung tissue inflamed and susceptible to infection. There has never been a better time to quit all tobacco products, including e-cigarettes!
