



## OCEANA LEADS HOSTS RIDE FOR RECOVERY EVENT

September 09, 2021 – September is National Recovery Month and in recognition Oceana LEADS is hosting a virtual 'Ride for Recovery' bike ride along the Hart-Montague Trail in Oceana County.

'Ride for Recovery' is a free event throughout the month of September that offers riders the opportunity to learn about opioid use disorder, local recovery resources, and the Oceana LEADS substance abuse prevention coalition at four kiosks along the route.
