

## MICHIGAN PFAS ACTION RESPONSE TEAM TO UPDATE WEXFORD RESIDENTS ON PFAS INVESTIGATION

March 29, 2022 – The Michigan PFAS Action Response Team (MPART) will update residents near Wexford-Missaukee Career Tech Center (CTC) on its investigation of PFAS contamination in private drinking water wells near the Wexford-Missaukee CTC on Wednesday, April 6, 2022.

MPART representatives from the Michigan Department of Environment, Great Lakes, and Energy (EGLE) and the Michigan Department of Health and Human Services (MDHHS) along with District Health Department #10 (DHD #10) will host a virtual community meeting on April 6, 2022 from 6:00 – 7:30 pm.

The meeting is planned as an online event, rather than an in-person meeting.
