- ☐ Personnel Committee did not meet.
 - All Staff Meeting scheduled December 1st at Timber Wolf Lake in Missaukee County and board members are welcome to attend.
 - One of our staff members Mary Rangel passed away unexpectedly. Mary worked in Newaygo County in the WIC department and was a long-time employee at the agency.
- ☐ Legislative Committee did not meet.

- Hughes reached out to the legislature to attend the December board meeting. Currently, three have indicated that they plan to attend.
- Update on Statewide Sanitary Code-tabled right now but hoping a new bill will be available Jan or Feb. The main issue is funding. Baldwin questioned if we need to take a position on this. Hughes reported that previously DHD10 had taken a position of opposition and will do it again later if need be. DHD10 has roughly 166,000 septic systems which would be 33,000 that would need to be completed annually. It's going to cause issues with staffing as well as funding for people to have it completed. In order to write out our own policy pertaining to this that would work for DHD10, it would require opening the sanitary code back up and that's not something we currently are wanting to do.
- Update on Senate bill 633-638 regarding statewide marketplace for health insurance-still waiting on the "why".
- Update on Senate bill 133 regarding opiate fatality review teams- looks at deaths associated with overdose and how to prevent it. Waiting for more information on that bill itself.

VII. Administration Reports

- Medical Director, Dr. Jennifer Morse shared her report on syphilis.
 - Infection with close lesion contact causes transmission.
 - Symptoms are unusual and confusing.
 - Wanted to discuss because it is still around, and infections have increased over the last 20 years; especially in women.
 - Last year 37 babies were born with syphilis and one of them in our district.
 - Oral penicillin is known to treat but there is a critical shortage of penicillin right now.
 - Recommendations by Dr. Morse:
 - O Support efforts to prevent and correct critical drug shortages.
 - o Support recommendation STI testing and appropriate safer sex programming.
 - Support appropriate community information sharing about STI illness and testing recommendations.

Approve recommendations made by Dr. Morse. Motion by Jim Maike, seconded by Ron Bacon, to approve the recommendations by Dr. Morse.

- □ Deputy Health Officer, Sarah Oleniczak not present to report. Kevin Hughes gave updates.
 - PHAB accreditation was completed, and we passed. This is a 5-year process and from now until 2027 we will work on determining if we want to go through the process again and if so, we will work on efforts to obtain re-accreditation at that time.
 - MDHHS accreditation is scheduled for June of 2024. This is not a pass/fail cycle, but we will be approaching it as such.
 - Molina has recognized our AHC as "exceptional" and is rewarding us with 14 apple iPad for patient intake. Letter from Molina is included in the packet.
- ☐ Health Officer, Kevin Hughes presented his report.

LEGISLATIVE UPDATENovember 21, 2023

Resolved Bills with MALPH Involvement

- **HB 4437** omnibus appropriations bill
 - Last action: Enrolled as PA 0119'23 on August 22, 2023
 - Sponsor(s): N/A / Rep. Angela Witwer (D-76)
 - Summary: Appropriations/budget for fiscal year 2024
 - → Relevancy: \$25 million increase in essential local public health services funding [see pg. 130 of PA 0119]
- "Filter First" package SB 0088 / HB 4341 (Clean Drinking Water Access Act) / HB 4342
 - **Last action:** Enrolled as PAs 0173'23 / 0154'23 / 0155'23 on October 19, 2023
 - **Sponsor(s):** Sen. Sylvia Santana (D-2) / Rep. Ranjeev Puri (D-24) / Rep. Cynthia Neely (D-70)
 - **Summary:** Require schools and childcare centers to develop a drinking water management plan and update that plan every five years
 - → EGLE and LARA have enforcement responsibilities
 - → Find Legislative Analysis here
 - MALPH's position: Supported. Negotiated language change to relieve enforcement burden from LHDs
- Kindergarten Oral Health package SB 0280 / SB 0281
 - Last action:
 - → SB 280 ordered enrolled on November 7, 2023
 - \rightarrow SB 281 enrolled as PA 0168'23 on October 24, 2023
 - Sponsor(s): Sen. Sam Singh (D-28)
 - Summary (SB 280): Create a requirement for a dental oral assessment for every child before entering kindergarten or first grade, whether through private provider or through DHHS-selected provider; if treatment needed, follow-up report required
 - → Removes sunset on program
 - → SB 281: Requires transparency in dental network leasing and lessens administrative burden for clinics
 - → Find bill analysis for SB 280 here and SB 281 here
 - **Related bills:** HB 4445 [companion bill to SB 280]
 - MALPH's position: Supported
- **SB 0031 / HB 4200** screening/testing for lead poisoning for children
 - Last action: Enrolled as PA 0146'23 / PA 0145'23
 - Find analysis of bill as enacted <u>here</u>

LEGISLATIVE UPDATE November 21, 2023

Actively Tracking as of Sine Die

- Statewide Septic Code HB 4479 / HB 4480
 - Last action: Introduced and referred to House committee (Natural Resources, Environment, Tourism, and Outdoor Recreation) on April 27, 2023
 - → Waiting for substitutes to be introduced
 - **Sponsor(s):** Rep. Phil Skaggs (D-80) / Rep. Carrie Rheingans (D-47)
- "Overdose Fatality Review Act" SB 0133
 - Last action: Ordered enrolled on November 9, 2023
 - Sponsor(s): Sen. Sean McCann (D-19)
 - **Summary:** Allow county/counties to establish an overdose fatality review team (with certain requirements)
 - → Find bill analysis for Senate version here
 - MALPH's position: Support
- **HB 4167** creation of rare disease advisory council
 - Last action: Passed House and referred to Senate Health Policy committee on March 23, 2023; reported favorably with substitute on November 8, 2023
 - Sponsor(s): Rep. Jason Morgan (D-23)
 - Summary: Creates a Rare Disease Advisory Council within DHHS and defines who
 must serve on the council
 - → Find bill analysis for House version here
 - **Related bills:** this bill is a reintroduction of HB 4654 from 2021-22
- **SB 480** partitioning of land parcels
 - Last action: Passed Senate and referred to House committee on Local Government and Municipal Finance on November 8, 2023
 - Sponsor(s): Sen. Kevin Hertel (D-12)
 - **Summary:** amends 1967 Land Division Act increases number of parcels in which a 10-acre parent tract could be split, from four to 20 and allows municipalities to authorize further partitioning if land meets certain requirements
 - → Find Senate fiscal analysis here
 - MALPH's position: Neutral. MALPH has concerns about well and septic requirements

- **SB 542** distribution of opioid antagonists
 - **Last action:** Introduced and referred to Senate Health Policy committee on October 3, 2023
 - Sponsor(s): Sen. Kevin Hertel (D-12)
 - **Summary:** Allows recipients of opioid antagonist orders from DHHS to choose the formulation, method of administration, and/or dosage of the antagonist
 - **MALPH's position:** Neutral. MDHHS and MAPPP have concerns.
- "Protect MI Kids" package SBs 647-654 regulations and licensing related to ecigarettes, menthol cigarettes, and other tobacco products
 - Last action: Introduced and referred to Senate Regulatory Affairs committee on November 1, 2023
 - **Sponsor(s):** Sen. John Cherry (D-27) / Sen. Sam Singh (D-28) / Sen. Stephanie Chang (D-3) / Sen. Sue Shink (D-14) / Sen. Paul Wojno (D-10) / Sen. Mary Cavanaugh (D-6)
 - Summary:
 - → SB 647 allows local jurisdictions to enact tougher restrictions on tobacco sales
 - → SB 648 increases tobacco taxes and enacts tobacco taxes on e-cigarette and vapes containing nicotine
 - → SBs 649 + 650 ends the sale of flavored tobacco products
 - → SBs 651 + 652 requires license for tobacco retailers (similar to liquor retail)
 - → SBs 653 + 654 repeals penalties for youth tobacco purchase, use, and possession
 - MALPH's position: Support

Monitoring

- HB 5077 / HB 5078 / HB 5178 / HB 5179 distribution of opioid antagonists and syringe exchange programs
 - Last action:
 - → HB 5077 / 5078 Introduced and referred to House Health Policy committee on October 3, 2023
 - → HB 5178 / 5179 Introduced and referred to House Health Policy committee on October 18, 2023
 - **Sponsor(s):** Rep. Curtis VanderWall (R-102) / Rep. Carrie Rheingans (D-47)

- **Summary:** Allows an agency that obtains an opioid antagonist to distribute that opioid antagonist to anyone / allows a person to establish a needle exchange program with DHHS approval and provides immunity from drug paraphernalia (etc.) prosecution
 - → Find summary of HBs 5077 / 5078 here
 - → Find summary of HBs 5178 / 5179 here
- MALPH's position: Support
- **SB 633-637** establishment of state health insurance exchange
 - Last Action:
 - → Introduced and referred to Committee on Health Policy on November 1, 2023
 - **Sponsor:** Sen. Kevin Hertel (D-12)
 - **Summary:** The bills would create a State-based insurance exchange (SBE) which would serve as a market for qualified health and dental insurance plans in the State
 - MALPH's position: Neutral
